**Position Title:** SUPERVISORY ELECTRICAL ENGINEER - 0850

**Work Schedule; Appointment Type:** Full-time; Permanent. Multiple positions may be filled from this notice.

**Responsibilities/Duties:** Serves as a Chief, Electrical Section, Design Branch

- Serves as Chief, Electrical Section of Design Branch, responsible for the technical and administrative supervision of electrical engineers. Plans, directs, manages and oversees the technical policies, standards and criteria of electrical engineering within the Far East District (FED). Programs include Military Construction (Army and Air Force), dependent schools, non-appropriated funded design, medical, family housing, host nation funded construction of the Army, Air Force, Navy/Marines; and those for other Federal agencies.
- Directs and manages the formulation and establishment of technical policies, guidance and instructions in electrical engineering for District-wide application. Responsible for District-wide staff mentoring and the professional and technical development of the respective disciplines. Serves as a member of Boards and/or ad-hoc committees as appointed.
- Plans, directs and manages the electrical engineering of FED's in-house design; the design review and quality assurance of both in-house and Architect Engineer contracted work; and provide technical support to all field operating elements. The incumbent should possess knowledge of availability of construction materials, engineering standards and construction practices to include climatic and environmental conditions in the ROK. Incumbent action will influence District-wide success in the area of technical quality, schedule and cost impacts. This will require knowledge of a wide range of functional and technical criteria to include DOD, Army, Air Force, Navy/Marines, ROK and other Federal agencies.
- Directs and is responsible for the coordination and integration of the engineering activities with other architectural and engineering disciplines. Responsible for overall coordination of section operations and assignments with other major engineering disciplines for the total execution of program and projects, and of advising management of such. Maintains and assures the integration of these functional and technical activities with other FED organizational elements, such as Programs and Project Management, Construction, Contracting and Resource Management Divisions and Counsel.
- As Chief of the Electrical Section, represents the Division in dealing with program and project proponents, provides leadership for meetings and conferences, participates in meetings and conferences where other military agencies, ROK Government officials and the Architect-Engineer firms are represented. Make presentations, which require extensive preparation and knowledge of technical subject matter. Represents FED on technical committees. Position requires frequent contact within and outside of the organization, as noted above. Make field visits to military installations to inspect projects under construction or recently completed to ensure compliance with design policy and criteria and to resolve technical problems.
- Exercise supervisory control over assigned staff in this section. Formulates internal working policies. Plans, assigns, directs, coordinates, monitors and reviews work of subordinates. Establishes priorities and prepares schedules for work completion. Reviews performance objectives and

standards prepared by subordinates and evaluates performance of subordinates. Recommends performance awards. Gives advice, counsel and instructions to individual employees on work, career development and administrative matters. Interviews candidates for vacant positions, making selections or recommendations for appointment, promotion or reassignment, involving, such positions. Hears and resolves complaints from both individuals and groups of employees. Effects disciplinary measures, such as warnings and reprimands. Recommends resolution and initiation of disciplinary action in more serious cases. Identifies development and training needs of employees and provides or makes provisions of such development and training. Approves leave for Subordinates. Prepares, implements and manages an operating budget. Reviews or approves within-grade increases, overtime expenses and employee travel expenses.

**Conditions of Employment:**

- U.S. Citizenship required.
- This position requires the employee to obtain and maintain a Secret clearance.
- EMERGENCY ESSENTIAL STATEMENT: This position is considered essential to support the Army's mobilization and wartime mission during periods of increasing tension or mobilization.
- This position requires license as a Professional Engineer at the time of appointment.
- Submit a Financial Disclosure Statement, OGE-450, upon entering the position and annually thereafter.

**Travel Requirement:** 15 % Temporary Duty Travel required

**Education Requirements:** Bachelor's degree (or higher degree) in engineering. This education must be reflected on your resume and transcript(s).

**Professional Registration or Licensure:** Current registration as a Professional Engineer (PE) by any State, the District of Columbia, Guam, or Puerto Rico required for GS-13 level.

**Relocation:** Permanent Change of Station (PCS) allowances may be authorized, subject to the provisions of the Joint Travel Regulations and an agency determination that a PCS move is in the Government Interest.

**Hiring Incentive:** Hiring incentives such as a recruitment/relocation incentive may be authorized (subject to available budget) if the selecting official determines the incentive is in the best interest of the government.
