<u>Responsibilities/Duties</u>: Responsible for reviewing, coordinating, monitoring, and providing interface with staff counterparts of various organizations.

- As the Design Manager (DM), serves as Contracting Officer's Representative (COR) for all A-E contract procurement actions and a technical member on the Project Delivery Team (PDT).
- Responsible for design management of all technical issues and ensuring quality of all engineering designs; reviews and interprets engineering data, criteria, and higher headquarters' policy and regulations.
- Resolve conflicts or delays to the timely completion of work. Recommends solutions to problems, which may
  involve technical and administrative changes.

## **Conditions of Employment**:

- U.S. Citizenship required.
- Position requires incumbent to obtain and maintain Secret clearance.
- Newly appointed employees required to serve a 2-year probationary period.
- This is an Army Acquisition, Logistics and Technology Workforce position. This position requires and Acquisition Level II Certification in Facilities Engineering within 24 months of entry on duty.
- Submit a Financial Disclosure Statement, OGE-450, upon entering the position and annually thereafter.
