Work Schedule; Appointment Type: Full-time; Permanent. Multiple positions may be filled from this notice.

Responsibilities/Duties: Responsible for planning, scoping, negotiating, and preparing documents for architectural and engineering contract services required in the preparation of plans, specifications, cost estimates, and design analyses by architect-engineer (A-E) firms.

- As the Government Negotiator (GN), works with project managers (PM) and customers to clarify requirements and develop statements of work.
- Participates in A-E selection process and works with PM, Cost, and Contracting for RFP development.
- Evaluates and negotiates A-E proposals and develops POMs and PNMs for A-E contract awards.

Conditions of Employment:

- U.S. Citizenship required.
- Position requires incumbent to obtain and maintain Secret clearance.
- Newly appointed employees required to serve a 2-year probationary period.
- This is an Army Acquisition, Logistics and Technology Workforce position. This position requires and Acquisition Level II Certification in Facilities Engineering within 24 months of entry on duty.
- Submit a Financial Disclosure Statement, OGE-450, upon entering the position and annually thereafter.

Travel Requirement: 10% Temporary Duty Travel required

<u>Education Requirements</u>: Bachelor's degree (or higher degree) in engineering or architecture. This education must be reflected on your resume and transcript(s).
