Work Schedule; Appointment Type: Full-time; Permanent.

Responsibilities/Duties: Serves as Chief, Cost Engineering Branch. With a workforce of professional engineers and architects, directs preparation of cost estimates and provides technical advice and assistance to the Chief, Engineering Division. Work involves cost estimating and technical review of design and construction products for all programs.

- Performs first line supervisory personnel management functions for the Branch.
- Plans project assignments and establishes cost parameters to ensure an even flow and distribution of work, the expeditious handling of priority projects, and the meeting of schedules and attainment of fiscal targets.
- Directs the preparation of cost estimates for in-house and contracted projects.
- Develops and monitors programmatic performance cost indicators with respect to Current Working Estimates versus Programmed Amounts for A-E and In-house designs.

Conditions of Employment:

- U.S. Citizenship required.
- Position requires incumbent to obtain and maintain Secret clearance.
- Newly appointed employees required to serve a 2-year probationary period.
- This is an Army Acquisition, Logistics and Technology Workforce position. This position requires and Acquisition Level II Certification in Facilities Engineering within 24 months of entry on duty.
- Submit a Financial Disclosure Statement, OGE-450, upon entering the position and annually thereafter.

Travel Requirement: 10% Temporary Duty Travel required

<u>Education Requirements</u>: Bachelor's degree (or higher degree) in engineering or architecture. This education must be reflected on your resume and transcript(s).

Certification: This position requires a CCE (Certified Cost Engineer)) or Certified Cost Consultants (CCC) certification.

Relocation: Permanent Change of Station (PCS) allowances may be authorized, subject to the provisions of the Joint Travel Regulations and an agency determination that a PCS move is in the Government Interest.
